



## Authorized Distributors (Primary Market)

**Authorized Distributors** are regulated entities that operate exclusively in the primary market for USTBL. They provide investors and market operators with access to subscription and redemption services in accordance with their licensed framework. Authorized Distributors may include OTC desks or regulated exchange platforms that are approved to support primary-market activity for USTBL.

## Authorized Participants

They offer trading services and market access through supported trading pairs, enabling investors to buy and sell USTBL on regulated platforms under their respective regulatory licenses. Authorized Participants include centralized exchanges and regulated broker-dealers authorized to offer secondary-market trading for USTBL.
